## **Introducing 4% Edge Checking**

If you currently have one of the following Astera checking account types, you will automatically be upgraded to Adventure's 4% Edge Checking on 11.1.2025.

- Check Plus Checking
  - S Checking Rasasa
- Kasasa Cash
- Choice Checking
- Kasasa Cash Back

With your new Edge Checking account, you can **earn up to \$400/year in dividends.** Members earn 4.07% APY on their Edge Checking balance (up to \$10,000) when they meet a few simple requirements.\* If you fail to meet the requirements in a given month, there's no penalty or fee!

\*APY = Annual Percentage Yield. Rate valid as of 7/1/2025 and is subject to change without notice. 4.07% APY is paid on balances up to \$10,000 provided the following qualifiers are met each monthly qualification cycle: 1) Twenty or more debit card purchases must post by 8:00 pm the last day of the month; 2) An ACH/Direct Deposit of at least \$100 per single deposit must post and clear the account within 30-days; 3) You must receive eStatements (no paper statements); 4) Must login to Online or Mobile Banking at least once during the month. If qualifiers are not met, 0.00% APY will be paid on all balances. Limit one account per individual. Personal accounts only. Primary account holder must be at least 18 years of age. Fees could reduce earnings.


