

# Youth Month Giveaway Rules

## **PRIZES:**

- 1) One (1) random winner will be chosen each week from our social media drawings to receive a \$25 gift card.
- 2) One (1) random winner will be chosen each week from all entry submissions from the scavenger hunt giveaway to receive a Kindle Fire 7 Tablet.

## **ODDS OF WINNING:**
